Summary - Wajahat and Shabnam RANA

In total, Wajahat Ali RANA and Shabnam RANA, collectively, are currently the registered owners of 8 properties in New South Wales. Interestingly, Shabnam RANA retains ownership over 7 of those 8 properties.

In relation to values of their current properties, they are valued, collectively, at over \$14,000,000. You will note that some property values were unable to be ascertained as yet. Further enquiries will be needed to be undertaken to determine their values.

In relation to the properties sold by Wajahat and Shabnam RANA, they have sold them for a combined total of approximately \$4,250,000 above the original purchase price.

In relation to the mortgages held on these properties, it will require more extensive research into each property, separately, to gather that information.



Findings

From our investigations into property holdings by the Directors of Qartaba Homes Pty Ltd – Kashif AZIZ, Muhammad Khurram JAWAID and Wajahat Ali RANA – it can be observed that the majority of the property held is registered to have been owned by their spouses. While information on the spouse of JAWAID cannot be determined at this time, it stands to reason that should that information come to light, he too will display the same characteristics as AZIZ and RANA. This ownership profile could indicate that they are trying to keep their family assets away from the ownership of Qartaba Homes Pty Ltd and it's active Directors.

The mortgages has not yet been obtained and the next process in this regard will be discussed with the client.

There were multiple incidents where the purchaser bought properties from a company known as Hume Homes Pty Ltd, mostly at a drastically reduced price according to estaimated market value. Some examinations were conducted on Hume Homes Pty Ltd which revealed it's Directors were, indeed, Kashif AZIZ, Muhammad Khurram JAWAID and Wajahat RANA and that the company is recorded as being a company 'Under Administration', since September 2023.
